CLASS A MEMBERSHIP ADMISSION AND STOCK SUBSCRIPTION AGREEMENT

This Class A Membership Admission and Stock Subscription Agreement (“Agreement”) is made by and between the undersigned applicant and Timber Professionals Cooperative Enterprises, a Wisconsin cooperative with offices at 3243 Golf Course Rd, Rhinelander WI 54501 (“TPCE”).

WHEREAS, applicant has reviewed TPCE’s Articles of Incorporation (“Articles”) and Bylaws (“Bylaws”), and represents that applicant meets the qualifications of TPCE and seeks to become a Member of TPCE; and

WHEREAS, TPCE believes that applicant should be admitted as a Member and as such, will further the interests, purpose, or operation of TPCE.

NOW THEREFORE, in consideration of the mutual covenants, terms, and conditions set out herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows.

1. Membership Approval. TPCE agrees to admit Member as a Member of TPCE. Member accepts admission as a Member, and acknowledges that it has reviewed TPCE’s Articles and Bylaws setting forth member rights and obligations, and agrees to comply with its member obligations in the Articles, Bylaws and any member policies that TPCE may adopt from time to time.

2. Subscription. Member hereby subscribes to purchase one (1) Class A Share of Common Stock for a total purchase price of \$100 (the “**Purchase Price**”), which shall be payable to TPCE within ten (10) days of after the date of acceptance by TPCE. Member ownership of Class A Common Stock is limited to one (1) share.
